AN ORDINANCE AMENDING SECTION 3, OF ORDINANCE NO. 21-618, THE ORGANIZATIONAL STRUCTURE AND STAFFING PATTERN OF THE CITY GOVERNMENT OF ISABELA, PARTICULARLY UNDER THE CITY DISASTER RISK REDUCTION MANAGEMENT DIVISION, OFFICE OF THE CITY MAYOR, ALL OF THIS CITY.

After due deliberation on the matter, on motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by all members present, **BE IT**

Ordained by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, **THAT:**

SECTION 1. – That the position of one Senior Labor and Employment Officer, of the City Public Employment Service Office, was mistakenly placed under the City Disaster Risk Reduction Management Division, Office of the City Mayor, all of this City.


