**AN ORDINANCE AMENDING ORDINANCE NO. 20-584, SECTION 5 (M), PRESCRIBING THE CURFEW HOURS WITHIN THE TERRITORIAL JURISDICTION OF ISABELA CITY.**

**WHEREAS**, Section 16 of the Local Government Code of 1991 mandates that, "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the general welfare" specifically on the promotion of the health and safety of its constituents and the maintenance of peace and order in their localities;

**WHEREAS**, Ordinance No. 21-633, an ordinance shortening the period of curfew hour, from 9:00 p.m. to 3:00 a.m., was enacted to allow people especially the business sector to recover economically;

**WHEREAS**, the imposition of the curfew hour plays a very important role in the effort of the City Government in containing the spread of the dreaded Corona virus disease that is taking life of the constituents;

**WHEREAS**, the imposition of the curfew hour do not only contain the spread of the deadly virus, but also deter the commission of criminal acts which is tantamount to the recovery of our local economy and safety of the inhabitants;

Be it ordained by the Sangguniang Panlungsod of Isabela City, Province of Basilan, **THAT**

**SECTION 1. AMENDMENT.** That Ordinance No. 20-584, Section 5(m), is amended, prescribing the curfew hours from 11:00 p.m. to 3:00 a.m., within the territorial jurisdiction of the City of Isabela, Province of Basilan.

**SECTION 2. EFFECTIVITY.** This ordinance shall take effect immediately upon approval.
