The *City Government of Isabela, Basilan*, through the *General Funds* intends to apply the sum of *Eight Hundred Thousand Pesos and 00/100 Centavos (Php 800,000.00)* being the approved budget for the contract (ABC) to payments under the contract for *Procurement of Fuel, Oil and Lubricants to be used by the City Engineer's Office, Isabela City, Basilan*. 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
4. Interested bidders may obtain further information from Bids and Awards Committee City of Isabela, Basilan and inspect the Bidding Documents at the address given below during **9:00 am to 5:00 pm, Monday to Friday.**
5. A complete set of Bidding Documents may be purchased by interested Bidders starting on **January 28, 2022** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Php 1,000.00.**

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

6. Bids must be delivered to the address below on or before **February 15, 2022 at 9:30 A.M., Sakayan Conference Room, Mayor's Office, City Hall Compound, Sunrise Barangay, Isabela City, Basilan.** All Bids must be accompanied by a bid security in Cash, Certified Checks or Bank Guarantee.

Bid opening shall be on **February 15, 2022 at 9:30 A.M Sakayan Conference Room, Mayor's Office, City Hall Compound, Sunrise Barangay, Isabela City, Basilan.** Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
