AN ORDINANCE TEMPORARILY SUSPENDING SECTION 5(F1)15, IMPOSITION OF MARKET FEES AND CHARGES, OF ORDINANCE NO. 15-438, OTHERWISE KNOWN AS THE REVENUE CODE OF ISABELA, DURING AND UNTIL THE COMPLETION OF THE REHABILITATION PROJECT OF THE OLD PUBLIC MARKET.

WHEREAS, due to the State of Health Emergency, people from all walks of life suffered the result brought by the Corona Virus Disease Pandemic, thereby limiting all kinds of activities;

WHEREAS, health over economy is being weighed and studied cautiously so as to recover economically but not sacrificing the well-being of the constituents;

WHEREAS, stall-owners from the Old Public Market were transferred to temporary locations to give way to the on-going rehabilitation projects being undertaken by the City Government Unit of Isabela in the Old Public Market, so as to possibly uplift the present recovering business condition in the market.

NOW WHEREFORE, upon motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by all members present, **THAT:**

SECTION 1. Section 5(F1)15, IMPOSITION OF MARKET FEES AND CHARGES, of ORDINANCE NO. 15-438, otherwise known as the Revenue Code of Isabela, is hereby suspended temporarily during and until the completion of the rehabilitation project of the old public market.

SECTION 2. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval and shall be revoked upon the completion of the rehabilitation project of the Old Public Market.
