AN ORDINANCE REALIGNING THE AMOUNT OF EIGHT MILLION PESOS (P8,000,000.00), TAKEN FROM THE APPROVED PROJECTS UNDER THE 20% DEVELOPMENT FUND OF THE ANNUAL INVESTMENT PLAN CALENDAR YEAR 2021.

After due deliberation on the matter, on motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by all members present;

Be it ordained by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, that:

Section 1. – The amount of **FOUR MILLION PESOS (P4,000,000.00)**, taken from the approved project under 20% Development Fund OF THE Annual Investment Plan CY 2021, entitled "Construction of Covered Court at Lampinigan Barangay, Isabela City in the amount OF Four Million Pesos (4,000,000.00), and "Construction of Covered Court at Baluno Barangay, Isabela

City, in the amount of Four Million Pesos (4,000,000.00), be realigned and re-appropriated for the improvement of City Hall Building including Improvement of Landscape of the City Hall Premises, in the amount of Four Million Pesos (4,000,000.00), and "Concreting of Road at Tabiawan Barangay in the amount of Four Million Pesos(4,000,000.00).

SECTION 2. - Effectivity - This Ordinance shall take effect upon its approval.
