ORDINANCE NO. 21-647

ENACTED: JULY 14, 2021

AN ORDINANCE AMENDING SECTION 5(m), OF ORDINANCE NO 20-584 OTHERWISE KNOWN AS AN ORDINANCE ESTABLISHING THE GUIDELINES DURING THE MODIFIED GENERAL COMMUNITY QUARANTINE CLASSIFICATION IN THE CITY, ALLOWING MINORS AGES 5 AND ABOVE, AND SENIOR CITIZENS TO GO TO OPEN AREAS OUTSIDE OF THEIR RESIDENCES SUCH AS PARKS, ATHLETIC FIELDS, RESORTS, AND BEACHES. PROVIDED, THAT CITY WIDE CURFEW SHALL CONTINUE TO TAKE FORCE AND IN EFFECT

WHEREAS, The National Inter-Agency Task Force on the Management of Emerging Infectious Diseases has issued guidelines in allowing minors and senior citizens under the Modified General Community Quarantine Classification to go outside of their residences but only in open areas;

WHEREAS, Under the said guidelines, minors and senior citizens are now allowed to go outside of their residence but only to open areas such as recreational parks, athletic fields, resorts, and beaches. However, they are still prohibited to go to Malls, Department Stores, Food Courts, places of worship, or any enclosed areas unless they are accompanied by their parents;

WHEREAS, the new guidelines set by the IATF will help our minors and senior citizens from the adverse psychological effects brought by the COVID19 pandemic.

NOW WHEREFORE, upon motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by all members,

Be it ordained by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, that:

SECTION 1. That Sec. 5(m). of Ordinance No. 20-584, establishing the Guidelines during the Modified General Community Quarantine classification of the city, be amended and thereby allowing minors aged 5 years old and above and senior citizens to go outside their residences to open areas only, like parks and beaches.


SECTION 2. The city-wide curfew hours from 9:00 P.M. to 5:00 A.m., shall continue to be strictly imposed.
