AN ORDINANCE REALIGNING THE AMOUNT OF TWO HUNDRED TWO THOUSAND NINE HUNDRED FIFTY (P202,905.00) PESOS, WHICH WAS TAKEN FROM THE SALARY SAVINGS OF TWO (2) VACANT POSITIONS, UNDER THE PERSONAL SERVICES, OFFICE OF THE CITY BUDGET. SAID AMOUNT WILL BE REALIGNED AND RE-APPROPRIATED TO AUGMENT THE PRESENT APPROPRIATION FOR OVERTIME AND NIGHT PAY, UNDER THE PERSONAL SERVICES, OFFICE OF THE CITY BUDGET, THIS CITY.

After due deliberation on the matter, on motion of Councilor Jashim I. Tiplani, duly seconded by all members present, **BE IT**

Ordained by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, **THAT:**

SECTION 1. – That the amount of Two Hundred Two Thousand Nine Hundred Fifty (P202,905.00) Pesos, which was taken from the salary savings of two (2) vacant positions, under the Personal Services, Office of the City Budget.

Said amount will be realigned and re-appropriated to augment the present appropriation for Overtime and Night Pay, under the Personal Services, Office Of The City Budget, This City.

SECTION 2 . - Effectivity - This Ordinance shall take effect upon its approval.


