AN ORDINANCE REALIGNING THE AMOUNT OF THREE HUNDRED FIFTY THOUSAND (P350,000.00) PESOS, WHICH WAS TAKEN FROM THE APPROPRIATION BALANCE UNDER THE MAINTENANCE AND OTHER OPERATING EXPENDITURES, OFFICE OF THE CITY VETERINARIAN, THIS CITY. SAID AMOUNT WILL BE REALIGNED AND RE-APPROPRIATED TO AUGMENT THE PRESENT APPROPRIATION FOR OTHER GENERAL SERVICES, MAINTENANCE AND OTHER OPERATING EXPENDITURES, OFFICE OF THE CITY VETERINARIAN, THIS CITY.

After due deliberation on the matter, on motion of Councilor Jashim I. Tiplani, duly seconded by all members present, **BE IT**

Ordained by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, **THAT:**

SECTION 1. – That the amount of Three Hundred Fifty Thousand (P350,000.00) Pesos, which amount will be taken from the appropriation balance of the following, under the Maintenance and Other Operating Expenditures, Office of the City Veterinarian, this City, to wit: Travelling Expenses in the amount of One Hundred Thousand (P100,000.00) Pesos, and Other Maintenance and Operating

Expenses-City Pound Program, in the amount of Two Hundred Fifty Thousand (P250,000.00) Pesos. Said amount will be realigned and re-appropriated to augment the present appropriation for Other General Services, Maintenance and Other Operating Expenditures, Office of the City Veterinarian.

SECTION 2. - Effectivity - This Ordinance shall take effect upon its approval.


