6. Bids must be delivered to the address below on or before March 7, 2022 at 9:30 A.M., Sakayan Conference Room, Mayor's Office, City Hall Compound, Sunrise Barangay, Isabela City, Basilan. All Bids must be accompanied by a bid security in Cash, Certified Checks or Bank Guarantee.

Bid opening shall be on March 7, 2022 at 9:30 A.M Sakayan Conference Room, Mayor's Office, City Hall Compound, Sunrise Barangay, Isabela City, Basilan. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
