### **INVITATION FOR NEGOTIATED PROCUREMENT TWO (2) FAILED COMPETITIVE PUBLIC BIDDINGS**

#### **CONSTRUCTION OF MARANG-MARANG PUBLIC CR AT PUROK 1,2 & 3, ISABELA CITY, BASILAN**

1. In view of the two (2) failed public biddings and one (1) failed negotiated procurement, the Local Government of Isabela City, through its Bids and Awards Committee (BAC) invites interested bidders to participate in the negotiated procurement for the CONSTRUCTION OF MARANG-MARANG PUBLIC CR AT PUROK 1,2 & 3, ISABELA CITY, BASILAN, in accordance with Section 53.1 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 otherwise known as the "Government Procurement Reform Act".
2. The Approved Budget for the Contract (ABC) for this procurement is Nine Hundred Ninety Nine Thousand Nine Hundred Ninety Nine Pesos and Ninety Three Centavos (Php 999,999.93), inclusive of all applicable government taxes and charges.  
Best and Final Offer received in excess of the ABC shall be automatically rejected at bid opening.
