A RESOLUTION AMENDING SEC. 30, STANDING COMMITTEES, OF RESOLUTION NO. 22-6402, OR THE INTERNAL RULES AND PROCEDURES OF THE SANGGUNIANG PANLUNGSOD.

WHEREAS, Section 50 (b) (1) of the Local Government Code of 1991, states that "The Organization of the Sanggunian and the election of its Officers as well as the creation of standing committees which shall include, but not limited to, the committees on appropriations, women and family, human rights, youth and sports development, environmental protection, and cooperatives, the general jurisdiction of its committee, and the election of chairman and members of each committee;"

WHEREAS, Resolution No. 22-6402, otherwise known as the Internal Rules and Procedures of the Sangguniang Panlungsod of Isabela, Province of Isabela, provides an existing Thirty Three (33) standing committees;



WHEREAS, Republic Act No. 9710 known as Magna Carta for women, "defines Gender and development (GAD) Program as the development perspective and process that is participatory and empowering, equitable, sustainable, free from violence, respectful of human rights, supportive of self determination and actualization of human potentials."

WHEREAS, the Sangguniang Panlungsod member creates Gender and Development Committee to facilitate the institutionalization of GAD mainstreaming activities, identify GAD strategies, programs, activities and projects in accordance with the identified priorities of the City;


NOW, WHEREFORE, upon motion of Councilor Karel Annjaiza R. Sakkalahul, duly seconded by members present,

BE IT RESOLVED, that the Sangguniang Panlungsod of Isabela City, Province of Basilan, amends Sec. 30, Standing Committees, of Resolution No. 22-6402, or the Internal Rules and Procedures of the Sangguniang Panlungsod.


