A RESOLUTION REQUESTING THE ACTING CITY TREASURER AND THE LOCAL ENTERPRISE DEVELOPMENT AND INVESTMENT PROMOTIONS OFFICE (LEDIPO), TO COMMENT AND RECOMMEND ON THE REQUEST OF HADJI AMIN U. AYARIN, PRESIDENT, WEST TERMINAL STORES, MENZI, ISABELA CITY.

WHEREAS, Section 458, (2)(ii), of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that, *subject to the provisions of Book II of this Code and applicable laws and upon majority of all the members of the Sangguniang Panlungsod, enact ordinances levying taxes, fees and charges, prescribing the rates thereof for general and specific purposes, and granting tax exemptions, incentives or relief;*

WHEREAS, a daily rental of One Hundred Seventy Four (P174.00) Pesos, was being charged to vendors located at the West Terminal, Menzi, Isabela City;

WHEREAS, undated letter of Hadji Amin U. Ayarin, President, West Terminal Stores, Menzi, Isabela City, to Honorable Jhul Kifli L. Salliman, City Vice-Mayor through Honorable Candu I Muarip, City Councilor, requesting to reduce the daily rental from One Hundred Seventy Four (P174.00) Pesos to Fifty (P50.00) Pesos, due to little income, which was received on January 19, 2023;

WHEREAS, the recommendations and comments of the Acting City Treasurer and the Local Enterprise Development and Investment Promotions Office (LEDIPO), are vital in the formulation of a legislative measure in addressing the above-request.


NOW, WHEREFORE, upon motion of Councilor Khaleedsher M. Asarul, duly seconded by members present,
