**A RESOLUTION RETURNING RESOLUTION NO. 01, S. 2023, AND RESOLUTION NO. 2, S. OF 2023, RESPECTIVELY, ALL OF BINUANGAN BARANGAY, REQUESTING THE ROOSTER CITY TO INCREASE ITS SHARE TO FIFTEEN (P15.00) PESOS, AND TO ALLOCATE SHARE FROM ITS DOOR RATE INCOME TO TWO (2) PESOS.**

**WHEREAS**, Section 391, (a)(1), of Republic Act 7160, otherwise known as the Local Code of the Philippines, states that, *the barangay shall enact tax and revenue ordinances, subject to the limitations imposed in this Code;*

**WHEREAS**, the enactment of a revenue-generating measure shall be in the form of an ordinance and not a resolution which is temporary in nature and, and shall undergo all the necessary requirements as being prescribed by law;

**WHEREAS**, Resolution Nos. 1 and 2, all series of 2023, of the Barangay Council of Binuangan Barangay, did not meet the requirements in the imposition of tax, fees and charges in the barangay;

**WHEREAS**, the said resolutions from Binuangan Barangay, this City, is hereby returned and recommended to be amended and to comply with the requirements in the enactment of a revenue-generating ordinance.


**NOW, WHEREFORE**, upon motion of Councilor Khaleedsher M. Asarul, duly seconded by members present,
