A RESOLUTION GRANTING AUTHORITY TO HER HONOR, MAYOR SITTI DJALIA T. HATAMAN, TO PURCHASE ONE (1) UNIT MOTOR VEHICLE (PICK-UP), IN THE AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND (P1,500,000.00) PESOS, TO BE USED FOR THE SERVICES FOR THE CHILDREN, WOMEN, AND YOUTH BY THE CITY SOCIAL WELFARE AND DEVELOPMENT OFFICE (CSWDO), THIS CITY.

WHEREAS, Sec. 16, of RA 7160, provides every Local Government Unit to exercise efficient and effective governance to ensure the general welfare within their territorial jurisdiction that will support the preservation and enrichment of culture, promote health and safety, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, ltr. (b) of Sec. 455, of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the City Mayor, shall exercise efficient, effective and economical governance the purpose of which is the general welfare of the city and its inhabitants;

WHEREAS, the City Social Welfare and Development Office lined up several interventions and services for the immediate care of children, women, and youth in the City of Isabela, Province of Basilan, is among the prime concern of the City Government of Isabela;

WHEREAS, a certification duly signed by the City Budget Officer, this City, certifying that the City Government of Isabela appropriated funds for the procurement of one (1) unit multi-purpose mobile transportation, as reflected under the Annual General Fund Budget for CY 2023.


NOW, WHEREFORE, upon motion of Councilor Khaleedsher M. Asarul, duly seconded by members present,
