A RESOLUTION GRANTING AUTHORITY TO HER HONOR, MAYOR SITTI DJALIA T. HATAMAN, TO PURCHASE ONE (1) UNIT UTILITY VAN , IN THE AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND (P1,500,000.00) PESOS, TO BE UTILIZED IN THE IMPLEMENTATION OF THE COMMUNITY-BASED REHABILITATION AND BARANGAY DRUG-CLEARING PROGRAMS OF THE CITY GOVERNMENT OF ISABELA, PROVINCE OF BASILAN.

WHEREAS, ltr. (b) of Sec. 455, of Republic Act 7160, otherwise known as the Local Government Code of 1991, *provides that the City Mayor, shall exercise efficient, effective and economical governance the purpose of which is the general welfare of the city and its inhabitants;*

WHEREAS, the City Government of Isabela, Province of Basilan, implements the Community-Based Drug Rehabilitation Program and the Barangay Drug-Clearing Program;

WHEREAS, said programs are included in the 2023 Annual Investment Plan for Peace and Order and Public Safety Plan


NOW, WHEREFORE, upon motion of Councilor James Abner S. Rodriguez, duly seconded by members present,

BE IT RESOLVED, that the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, grants authority to Her Honor, Mayor Sitti Djalia T. Hataman, to purchase one (1) unit utility van , in the amount of One Million Five Hundred Thousand (P1,500,000.00) Pesos, to be utilized in the implementation of the Community-Based Rehabilitation and Barangay Drug-Clearing Programs of the City Government of Isabela, Province Of Basilan.


