**A RESOLUTION GRANTING AUTHORITY TO HER HONOR, MAYOR SITTI DJALIA T. HATAMAN, TO PURCHASE ONE (1) UNIT MOTORCYCLE , IN THE AMOUNT OF ONE HUNDRED THOUSAND (P100,000.00) PESOS, TO BE UTILIZED BY THE PHILIPPINE DRUG ENFORCEMENT AGENCY (PDEA), THIS CITY.**

**WHEREAS**, Itr. (b) of Sec. 455, of Republic Act 7160, otherwise known as the Local Government Code of 1991, *provides that the City Mayor, shall exercise efficient, effective and economical governance the purpose of which is the general welfare of the city and its inhabitants;*


