**WHEREAS**, Section 479, (2)(vi) of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the Civil Registrar shall file, keep and preserve in a secure place the books required by law;

**WHEREAS**, the ground floor of the Sangguniang Panlungsod Building, previously was temporarily occupied by the Office of the City Civil Registrar before they were transferred to their new office building, leaving some files and making this now as a temporary storage facility;

**WHEREAS**, to be more accessible to the constituents of the City, the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, will now be utilizing the ground floor previously occupied by the Office of the Civil Registrar, as office for the City Councilors and their staff.


**NOW, WHEREFORE**, upon motion of Councilor James Abner S. Rodriguez, duly seconded by members present,


