A RESOLUTION ADOPTING THE SOCIAL PROTECTION HANDBOOK OF THE CITY GOVERNMENT OF ISABELA.

WHEREAS, Section 9 of the 1987 Philippine Constitution, provides that *“The state shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all”*;

WHEREAS, a Joint Memorandum Circular No. 1 dated January 23, 2015 of the Department of Social welfare and Development (DSWD) and the Department of Interior and Local Government (DILG), enjoins all provinces, cities, municipalities, *to use the Social Protection handbook for local planning, budgeting, implementing, monitoring, and evaluating Social Protection Programs*;

WHEREAS, the Social Protection Handbook is a set of policies and programs designed to reduce poverty and vulnerability to various risks and enhance the social status and rights of the marginalized by promoting and protecting their livelihood and employment against hazards and sudden loss of income, and improving their capacity to manage risk;


NOW, WHEREFORE, upon motion of Councilor Bimbo E. Epping, duly seconded by members present;
